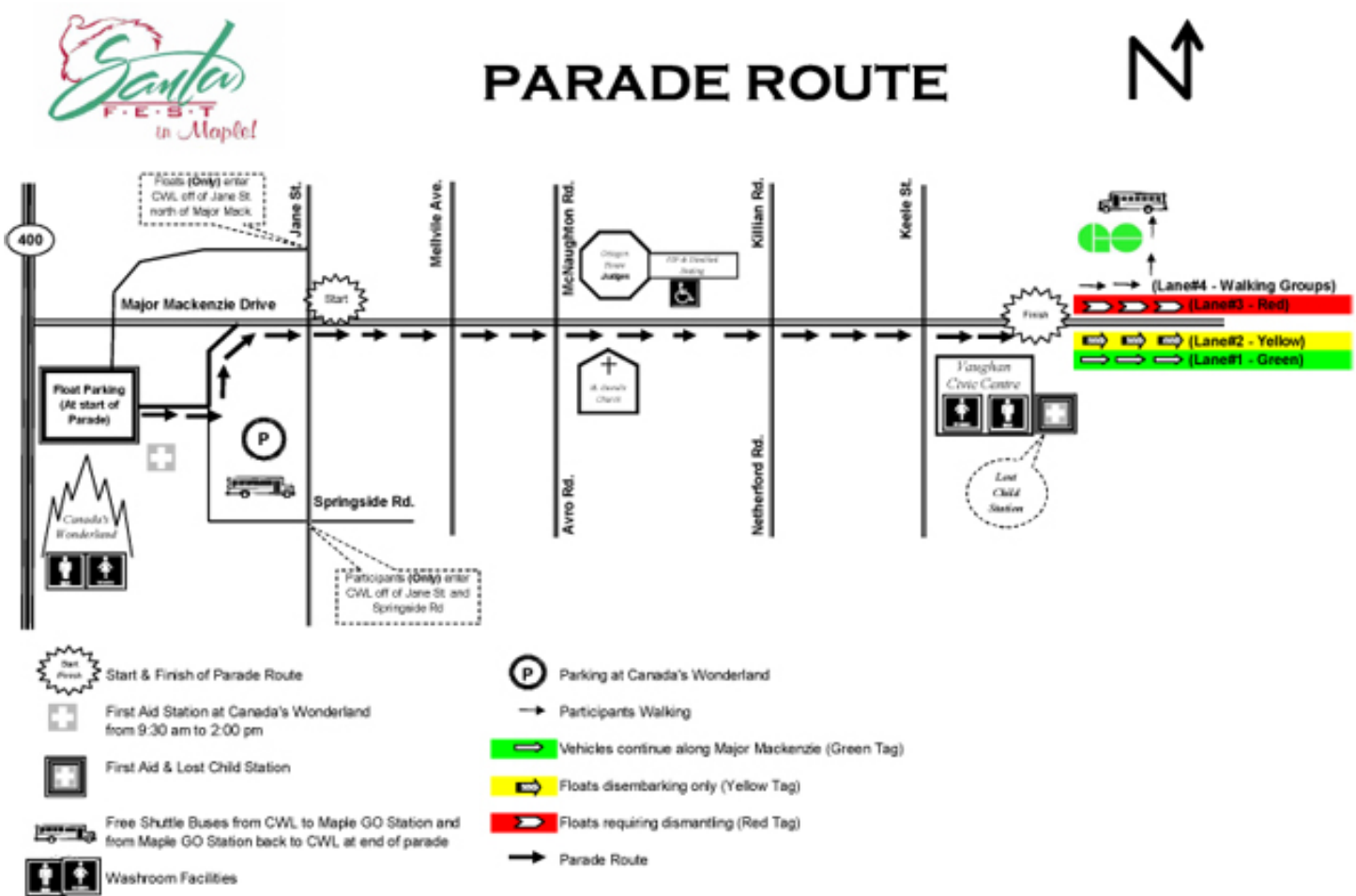

1. To waive any and all claims that I may have in future against SantaFest in Maple AND OTHERS.
2.
